

100 Point Identity Check

Acceptable Documentation for 100 Points of ID

Total points must equal or exceed 100 points and consist of at least one primary document.

Primary identity documents

Full Birth certificate (not extract) <i>English translation required if the document is in another language.</i>	Name	70
Australian or New Zealand Citizenship Certificate	Name	70
Certificate of Identity issued by the Australian or New Zealand Government to refugees and non Australian/New Zealand citizens for entry to Australia/New Zealand	Name	70
Driver Licence/Learner's Permit (all countries but must include Name and Photo) <i>English translation required if the document is in another language.</i>	Name, Address, Photo	40
Government employee ID (Australian Federal/State/Territory or New Zealand equivalent)	Name, Photo	40
Current Tertiary Student Identification Card (all countries but must include Name and Photo) <i>English translation required if the document is in another language.</i>	Name, Photo	40
Photo identification card issued for regulatory purposes (e.g. Aviation/Maritime Security identification, security industry etc.) <i>English translation required if the document is in another language.</i>	Name, Photo	40
Australian or New Zealand Firearms Licence	Name, Photo	40

Points of ID - Further details

Documents supplied must equal or exceed 100 points. The combination of Applicant's identity documents must include the Applicant's **full name and date of birth**.

At least one Primary document needs to be provided.

Change of Name – Where the name displayed on a document varies, a proof of name change issued by a State or Territory Registry of Births, Deaths and Marriages will be required.

Please note, a proof of name change does not count towards 100 points.
